GUIDELINES FOR A SUCCESSFUL MEMBER MIXER

Provided by Associated Builders and Contractors of Greater Houston

Thank you for your interest in becoming an ABC Member Mixer host! Member mixers are an excellent way to bring members and potential business partners to you. Depending on location, member mixers are designed to draw an average of 50 members. Previous member mixer locations have ranged from office and jobsite locations, to restaurants and pubs with located throughout the Greater Houston area. Here are some tips to consider when planning a Member Mixer with ABC.

Logistics

- Lock in a member mixer date at least 60 days before the actual mixer. This allows for proper event marketing.
- Host is expected to provide a venue large enough to accommodate 30 to 50 guests comfortably keeping social distancing guidelines in mind.
- Make sure there is ample parking.
- If an outdoor venue is selected, take consideration of weather patterns.

Event Marketing

- ABC will create online event registration site and event flyer.
- ABC will post event on website calendar, in e-newsletter and across the ABC social media platforms.
- ABC will provide a photographer and will post event photos on our Flickr account

At the Event

- ABC staff will need 2 tables for registration
- ABC staff will register and help welcome guests, introduce and thank you as host and may provide a brief statement during the Mixer
- As the host, you/your team should make it a priority to introduce yourself to every attendee. Don't forget your business cards.
- If mixer is at your business, consider conducting a tour or two.
- Have your company's marketing materials available.

Food/Beverages

- Plan for enough food to feed 30 to 50 attendees. Don't forget to account for plates, napkins and cutlery (if needed). Please also account for trash receptacles

If you are providing alcohol (recommended), host is required to follow all Texas Alcoholic Beverage Commission (TABC) laws/rules. For more information, click [HERE](https://gov.texas.gov/music/page/special_events). https://gov.texas.gov/music/page/special_events

Other

- You must be a current ABC Member to host a Mixer
- We suggest that you visit other mixers to see how they run, if possible.
- We ask that you provide at least one door prize or raffle item. Value \$25 to \$50.
 - Don't forget raffle tickets and a collection bucket (ABC can assist with this if needed).
- Keep music volume low to allow for conversations

ELIGIBILITY

Project(s) must be completed by an ABC member in good standing. Eligible projects must meet the following standards:

- Project(s) with a safety-related fatality, regardless of contractor trade, will NOT be considered for an Excellence in Construction award.
- General Contractors and Specialty Contractors are eligible to submit.
- Projects must be completed between October 2018 and October 2020*.
- Projects built outside of Houston will be accepted if portions of the project were managed through member's Houston office.
- All entries must follow the Entry Criteria section of this booklet.
- A \$300 entry fee must accompany each project submission.
- Entries must be completed electronically, visit www.abchouston.org or call 713-523-6222 for more information.
- Notify Mimi Wright at the ABC office of intent to submit by Friday July 3, 2020 by email at m.wright@abchouston.org. Please state project(s) name and category(s) if known.
- All completed entries must be submitted online via ABC provided Dropbox link no later than 4pm on Friday, August 7, 2020.

JUDGING

A panel of judges from the Owner, Architect and Engineering communities will review, evaluate and select EIC winners. Entries must earn a cumulative minimum of 85 points to be eligible to win an ICE award and must earn a cumulative total of at least 70 points to qualify for a Merit Award. Only one ICE award will be given in each category. Each project will be judged individually; consequently, awards may not be given in all categories. No member or staff of the ABC Greater Houston Chapter will participate as judges. Winners will be announced at the Excellence In Construction awards banquet to be held on October 22, 2020. The Judging Committee reserves the right to reassign a project to a different category or realign categories.

ENTRY CRITERIA

NOTE: Entries will only be accepted electronically via a Dropbox folder link that will be emailed to you once your Intent to Submit is received. All criteria outlined in this Call For Entry document must be included within your Dropbox folder. Entries should be uploaded as a single PDF file which includes each section in this document. Photos should be incorporated into your PDF file AND placed as .jpg files in a photo file provided within your project Dropbox link. If you are submitting more than one project, you will be provided with a Dropbox folder for each individual entry. To get your Dropbox folder link, please email m.wright@abchouston.org.

OVERALL PRESENTATION - 5 POINTS

- Upload one PDF document in entry folder with all sections included and labeled, which is pleasing to the eye and legible. Points will be deducted for font that is too small, or difficult to read. Photo folder contains .jpg photos as requested in the photo section of this call for entry.
- Points will be deducted for grammatical errors, spelling mistakes and other typographical errors.


CONTRACTED SCOPE - 10 POINTS

- Include up to one full page detailing the contract scope, ensuring legibility when selecting font design and size.
- Provide a description of your scope for this project including type of construction, size of project, contract value, length of project, and percentage of labor that is self-performed. Provide a list of all contractors on this project and designate which are ABC members (find members online at <http://web.abchouston.org/search>).
- Describe the opportunities you provided to the construction community to participate based on merit.

NARRATIVE - 30 POINTS

- Include up to four pages, ensuring legibility when selecting font design and size.
- Provide a written narrative indicating why this project is special and why it qualifies for an award. The focus of the narrative should be the construction (i.e. erection, installation, modification, grade footprint, etc.) of the project. Be sure to include the following items:
 - Describe any innovative programs relating to quality control
 - Describe any innovative programs relating to scheduling
 - Describe any value analysis/engineering process used on the project
 - Indicate any special obstacles you overcame in completing the project
 - Describe any difficulties or extenuating circumstances encountered in completing the project
 - Describe any innovative programs or methods related to productivity


PHOTOGRAPHS - 8 POINTS

- Include up to 10 quality photographs (8-10 recommended) of the project in your PDF presentation photo section that are clear of descriptions or captions, preceded by one typed page that includes photo descriptions/captions for each photo. Include the same (up to 10) photos in a .jpg file format and the one page photo description guide inside your dropbox photo folder (these will be used for marketing purposes).
 - To obtain maximum points, include "in progress" photos for new construction or "before and after" photos for restoration and renovation projects.
 - It is recommended to include photos that are relevant to the challenges and solutions outlined in the narrative.
 - Your JPG digital photos are required to be a minimum of 300 dpi resolution.
 - The photographs in your photo folder may not be submitted within a software program such as PowerPoint or Acrobat and must not include any text or framing that affects the photo.
 - Absolutely no videos are accepted.
 - Photographer's Use Authorization: If any of photos being submitted were taken by a third-party photographer, the photographer's written authorization to use the photos is required. There are two ways to comply: (1) the photographer can sign and date the licensing agreement (included in your dropbox folder), or (2) applicant must submit a letter from the photographer giving ABC authorization to use the photos, which must follow the licensing agreement. The letter should be scanned and included in your dropbox folder.

SAFETY – 31 POINTS

- Did the applying company have a safety-related fatality within the current program year (Oct. 16, 2019-Oct. 15, 2020)? If yes, your company is not eligible.
- Did your company have a safety-related fatality within two or three years of the current program year (Oct. 16, 2015-Oct. 15, 2017)? If yes, answer the questions below.
 - What was the violation type as determined by OSHA (i.e. Willful, Serious, Repeated, Other-than serious, No violation was cited)?
 - Date and location of incident
 - Were there any fines, citations or penalties issued? If so, by whom (i.e. OSHA, Police, Department of Transportation, etc.)?
 - Provide a written report up to five pages that details the following:
 - A full account of the incident and the investigation
 - What corrective actions were taken immediately?
 - What corrective actions were taken culturally?
 - How was accountability addressed?
 - What procedural changes were made?
 - Was there an overall evaluation of the company safety policies, and if so, what changes were made?
 - If the fatality occurred within two or three years prior to this program year (Oct. 16, 2015-Oct. 15, 2017), provide details as to how your company has implemented the changes discussed above and how it has affected the overall safety performance.
- Did this project have a safety-related fatality? If yes, this project is not eligible.

- Provide the project’s organizational chart identifying the person responsible for safety.
- Does your company conduct a new employee safety orientation? If yes, include a copy of the agenda.
- Were toolbox safety meetings held with employees? If yes, were these meetings documented and what was the frequency of meetings? Include a one-page summary or an example up to two pages.
- Did your company regularly establish pre-task safety planning prior to beginning work on this project? If yes, provide at least one example.
